Office Order

In convergence with the Animal and Fisheries Resources Department (AFRD), Government of Bihar, a total of **1,250 Pashu Sakhis** from the districts of Patna, Nawada, Nalanda, Aurangabad, Bhojpur, Muzaffarpur, Gaya, Rohtas, Jamui, Sitamarhi, Banka and Purbi Champaran have been trained under the **A-HELP initiative** over the past three years.

At present, these Pashu Sakhis are actively engaged in delivering essential livestock management services in their respective areas. Their key responsibilities include deworming, vaccination, artificial insemination support, primary animal health care, and awareness generation on various government livestock schemes. Their services play a vital role in strengthening rural livestock development, improving animal health, and enhancing the livelihoods of rural households.

Over the years, the contribution of Pashu Sakhis has been commendable, with a significant positive impact on community-level livestock management. To ensure the continued improvement and effectiveness of their services, it is essential that they receive periodic updates on new technologies, improved practices, updated medicines, and ongoing government schemes.

In this context, a **Refresher Training Programme** for Pashu Sakhis working under the A-HELP initiative will be organised at the **Seminar Hall during the Saras Mela at Gandhi Maidan**, from **16th to 21st December 2025**. The training will focus on scientific livestock management, vaccination protocols, reproductive health services, and other technical areas necessary for effective field-level service delivery. The detailed training schedule is enclosed as Annexure.

Instructions:

- The Manager Livestock/YP-Livestock of the concerned district shall scrutinize the list of A-HELP trained Pashu Sakhis with their mobile number, prepare the final list, and share it with Ms. Rachna Priyadarshani, Manager Livestock, SPMU, by 14th December 2025.
- The Manager Livestock/YP-Livestock of the concerned district shall act as the nodal
 officer for coordination and facilitation of Pashu Sakhis and ensure their participation
 as per the schedule attached in the annexure. They shall also attend the training as
 per the schedule.
- For the seating arrangement and conference facilities (Projector, Mic, etc) contact Farhat Praveen (Young Professional) Mobile no. 6363109925.
- Participants (A-HELP Pashu Sakhis) will travel from their residence to the venue using public transport. They will be entitled to travel allowance as per actuals and a food allowance of Rs. 200 during travel. The expenditure on travel and food shall be booked under B.2.4.3: Honorarium to Livelihood CRPs.
- The DPMs of the concerned districts shall ensure compliance with all the above instructions.
- The Dairy ,Fisheries and Animal Resources Department will provide the necessary training materials and basic amenities, including bag, register, pen, apron, cap, drinking water, seating arrangements, etc.

- Dr. Pramod Kumar (Mob. No. 9431255990) will be nodal person from Department of Dairy ,Fisheries and Animal Resources. Dr. Pramod Kumar will ensure availability of resource person for refresher training program as per the schedule mentioned in annexure and provide the list of resource person with contact details by 15th December 2025.
- Dr. Pramod Kumar will be responsible for registration of participants. He will ensure to share a copy of registration details to Ms. Rachna Priyadarshani, Manager Livestock, SPMU.
