#### **OFFICE ORDER**

"Revision of Selection and Eligibility Criteria for Livelihoods Cadres – Pashu Sakhi, Matsya Sakhi, Poultry Resource Person and Village Resource Person"

With reference to Office Orders issued vide BRLPS/Project/463/13/Vol-II/794 dated 08.06.2018, BRLPS/Project/463/13(Vol.-II)/56585/2023 dated 23.02.2023, BRLPS/Proj-IBCB/1972/21/2673 dt. 30.09.2025, BRLPS/Proj-OF/464/13/181 dated 15.04.2025, BRLPS/Proj-IBCB/1972/21/2735 dt. 06.10.2025, BRLPS/Proj/231/11/838 and BRLPS/Proj-Livestock/1726/20/522 dated 17.06.2021, Office order no.- BRLPS/Proj-IBCB/1982/21/2733, Dated- 06/10/25 , BRLPS/BTDP/ProjLH/1132/17/1/27774/2022 dated- 27/08/2023—the selection criteria and related guidelines for Farm and Livestock Cadres – namely Pashu Sakhi, Poultry Resource Person and Matsya Sakhi and Village Resource person a – have been previously circulated. In continuation of the aforementioned policy notes and orders, the selection and eligibility criteria for Farm and Livestock Cadre roles are hereby revised as follows:

Henceforth, the selection of Farm and Livestock cadres shall be limited to the existing pool of respective cadres. The existing VRPs may be assigned additional responsibilities as Pashu Sakhi, Matsya Sakhi, or Poultry Resource Person. Similarly, in areas where no VRP is currently placed, the existing Pashu Sakhi, Matsya Sakhi, or Poultry Resource Person may be assigned the additional role of VRP.

(Exceptional case: If no existing cadre is available, in that case, new selection may be carried out with proper justification and approval of the DPM).

### 4. Honorarium Guidelines

Cadre selected for an additional role shall remain eligible to continue receiving the honorarium and incentives for her original role. In addition, for the additional role, she will be entitled to receive **fixed additional remuneration** and **the full incentive** as per the respective cadre policy. Detail Honorarium Structure for additional role as Livestock cadre are mentioned below:

All previous norms and policies shall remain unchanged, except for the revised candidate sourcing criteria mentioned above. These revisions shall come into effect immediately and supersede all prior guidelines regarding the selection and eligibility for these roles.

#### Note:

- 1. These revisions shall be effective from the date of issue of the Office Order.
- 2. DPMs and BPMs are directed to ensure dissemination of this office order to all relevant personnel/officials under their respective units.
- 3. BPMs must further communicate the revised criteria to all livestock theme cadres (Pashu Sakhis, Matsya Sakhis and Poultry Resource Persons) and associated CLFs/PGs/VOs.
