- c. Bidder Should have experience in the supply of food items to any Government Department/Government Organization/Government Body/ Public Sector Undertaking. One Work order from any Government Department/Government Organization/Government body/ Public sector undertaking should be submitted in support of experience of work.
- d. The Bidder shall not be under a declaration of ineligibility for corrupt or fraudulent practices and should not be blacklisted by any State Govt./Central Govt./PSU for any reason in the last 5 years across India. Notarized undertaking to this effect should be submitted
- e. The bidder should have Minimum Average Annual Turnover of Rs 50.0 Lakhs for the last three financial years (2023-24, 2022-23 & 2021-22). CA Certificate with UDIN number should be attached.
- Bidder should have presence in Bihar. Notarized undertaking to this effect should be submitted.
- g. Bidder should have ability to deliver above said items anywhere in Bihar. Undertaking to this effect should have submitted.
- Bidder may quote rates for one Lot or more than one Lot. However, it would be mandatory to quote rate for all the items in a lot.
- Bid Security- Bidder has to submit bid security of INR 25,000/- (INR Twenty-five thousand Only) in the form of Demand Draft, in the favor of Bihar Rural Livelihoods Promotion Society payable at Patna.

Bidder seeking exemption from EMD as per Bihar Financial Rules shall have to furnish Valid MSME certificate with their technical bid. EMD of the unsuccessful bidders will be returned after the signing of the agreement with the successful bidder. The EMD will be forfeited if the bidder withdraws amends, impairs, or derogates from the tender in any respect within the validity period of the tender. Bids received without bid security will be treated as non-responsive and will not be evaluated.

Delivery time-lines

Delivery is to be made in all DKR (approximately 850 units) across 38 districts of Bihar. Multiple purchase orders with delivery timeline will be issued by different Community Based Organization (CBOs) during the period of rate of contract.

- Liquidated Damages (for delays in supply) --- An amount equivalent to 0.07 % per day will be deducted from the bill amount of bidder for delayed quantity. On further delays, purchase order may be cancelled.
- Validity of Bid- Bid shall remain valid for a period not less than 180 days after the deadline date specified for submission.
- 10. Bidder should keep technical proposal in one sealed envelope and financial proposal in second sealed envelope. Both the technical and financial proposal envelopes should then be kept in another big envelope duly sealed, otherwise Bid will be considered as non-responsive. All the envelopes should be superscribed having Technical Proposal and Financial Proposal with

11. Evaluation of Bids

The Purchaser will evaluate and compare the bids determined to be substantially responsive i.e. which

- (a) Are properly signed; and
- (b) Conform to the terms and conditions, technical specifications and qualification criteria.
- (c) Offered price should be valid for two years (Rate contract) for above items.
- (d) Evaluation will be made item-wise for each lot.

10. Award of Rate contract:

- Phase I It is a two-envelope bidding process. Financial bids of only those bidders
 will be opened for financial evaluation who will qualify in eligibility criteria as
 defined above.
- Phase II- Lowest quote in each lot should be valid for two (02) years as per price format and same will be considered as L1 price for the concerned a lot.
- Phase III- Rate contract valid for 02 (two) years with L1 bidder will be signed between concerned CBO & successful bidder for each lot.
- Negotiations may be held with other bidders on L1 rate.
- 11 Notwithstanding the above, the Purchaser reserves the right to accept or reject any bids and to cancel the bidding process and reject part/all bids at any time.
- 12. Agreements will be signed with the successful bidder and concerned CBO initially for a period of two (02) years which may be extended for further year upon mutual consent of the parties.

Quality Verification: -.

Quality will be verified by concerned CBO. The quality verification will be done at supply site and bidder or their authorized representative must be present to sign the verification report.


If any deviation is observed in the quality, bidder may be asked to replace/rectify the same. In case of replacement, the cost towards taking back the defective item and supply of replacement items will be the sole responsibility of the supplier.

- 14. The bidding agency shall be a single entity. Joint Venture/Consortium is not allowed. Subletting will not be allowed.
- Bihar Financial Rule and its amendments issued time to time will be considered for evaluation of proposal.
- 16. Bidder whose GST number is suspended / cancelled as per GST website will not be considered for evaluation.
- Bidder has to mention the name of product in their financial proposal.

- 20. An amount equivalent to five percent (5%) will be retained from each invoice as performance security. The performance security will be returned to supplier without any interest after successful completion of each year under agreement.
- 21. Payment will be made within 45 days by the concerned CBO after successfully supply and quality verification and upon submission of invoice (e-way bill if required) against each purchase order (excluding Sundays and Holidays). The challan should be duly signed and stamped from the concerned office. Statutory deductions, if any, shall be made at source. No Advance Payment will be made.
