4. Eligibility Criteria

- Bidder should be registered with GST. Photocopy of GST certificate should be submitted
- Bidder should have experience for providing internet services in any Government department / Government organization/ Government Body / Public sector undertaking / Local Bodies in India. Signed photocopies of at least One Single Work orders for providing Internet Services to any Government department / Government organization/ Government Body / Public Sector Undertaking/ Local Bodies in India along with completion certificate/s or any document in support of completion of work should be submitted.
- Bidder should have not been debarred/ blacklisted/ any legal action taken by any Government department / Government organization/ Government Body / Public sector undertaking / Local Bodies in India. Undertaking to this effect should be submitted.

5. Bid Price

- The requirement of bandwidth may increase/decrease, if required.
- The price shall be quoted for all the items strictly as described above and for full work including installation, configuration and commissioning.
- Interlineations, corrections, erasures and/or over writings shall be valid only if initialed by the persons or persons signing the bid.
- Applicable GST must be clearly stated. All duties, taxes, freight, insurance, delivery charges and other levies payable by the contractor under the contract shall be included in the quoted price.
- The rates quoted by the Bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- The Prices should be quoted in Indian Rupees only.

g) Discount offered, if any, and conditions thereof must be clearly stated in the bid itself.

h) Statutory deductions will be made at source, if applicable.

6. Submission of Bids:

- A Bidder shall submit bid in sealed envelope using their own stationery. A Bidder shall not submit more than one bid.
- The Bidder should mention full detail specifications of the service/items quoted.
- Envelope containing bids must bear, on the cover itself, name and full address of the Bidder. Bid number and date & time of bid opening shall also be super-scribed on the cover.
- For bids submitted by post or courier, it is Bidder responsibility that bids reach the purchaser's office before the scheduled time of closure of submission of bids.

7. Bid Security:-An amount of Rs. 5,000.00 (Rupees five thousand only) has to be deposited as bid security in the form of Demand Draft or Bank Guarantee in favor of Bihar Rural Livelihoods Promotion Society, Patna. The Bank Guarantee should be valid for 6 months from the date of opening of bid. The Bank Guarantee should be issued from any schedule bank.

Bidder seeking exemption from EMD as per Bihar Financial Rules shall have to furnish valid MSME certificate of Bihar registered under category 61104 which their bid. EMD of the unsuccessful bidders will be returned without any interest after the signing of the agreement with the successful bidder. The EMD will be forfeited if the bidder withdraws amends, impairs or derogates from the tender in any respect within the validity period of the tender.

Bids received without bid security will be treated as non-responsive and will not be evaluated.

If Tender process will be cancelled, EMD returns to all bidders.

8. Validity Period of Bid

Bid shall remain valid for a period not less than 90 days after the deadline date specified for submission.

9. Evaluation of Bid The Purchaser will evaluate and compare the bid as a whole determined to be substantially responsive i.e., which

- Are properly signed;
- Conform to the terms and conditions, technical specifications, and Eligibility criteria along with requisite Bid Security.
- Evaluation of bid shall be made for whole service. For this purpose, all sub-items and accessories, if any, of an item will be taken together and considered as one item.
- GST in connection with services shall be taken into account in evaluation. GST amount in the attached price schedule should be clearly mentioned.
- Bihar Financial rule and its amendment time to time will be considered in evaluation process.

10. Award of contract:- The Purchaser will award the contract to the Bidder

- a) whose bid has been determined to be substantially responsive; and
- b) who, in the assessment / judgment and sole discretion of the BRLPS, has technical capability to execute the contract; and
- c) who has quoted the lowest evaluated price for the whole services
- d) In case L1 agency fails to commence the work on time or otherwise, the work may be awarded to L2 agency on L1 rate.

11. Notwithstanding the above, the Purchaser reserves the right to accept or reject any bid or to cancel the bidding process at any time prior to the award of contract without assigning any reason thereof.

12. Prior to expiration of the bid-validity-period, the award of work by the Purchaser will be notified to the Bidder, whose offer has been accepted. The terms of the accepted offer/offers shall be incorporated in the contract agreement.

13. BRLPS will not purchase any additional hardware and Bidder will have to provide all the required hardware/s for establishing the connection.

14. All the Installation, commissioning and configuration has to be done by Bidder / Service provider and billing start date should be after successful installation and its verification by IT team of BRLPS.

15. Warranty: Maintenance of provided hardware (Router, Modem, Connecting devices etc.) has to be done by the Bidder.

16. Bidder has to provide name and mobile number of one nodal staff to resolve all the issues related with this work. In addition to that, Bidder has to provide online portal/ Dashboard for live monitoring the connection.

17. Bidder has to provide one time and recurring cost separately.

18. Bidder will do a preventive maintenance once every quarter.

19. Bidder has to do all Integration / configuration with LAN.

20. Integration / configuration of Static IPs with local LAN IPs has to be done by Bidder.

21. Place of installation will be provided by Bihar Rural Livelihoods Promotion Society.

22. Initially the assignment will be awarded for ONE YEAR which may be extended for further two years subject to need of BRLPS, satisfactory service and mutual consent of the parties

23. The proposed ILL connection will include stable and uninterrupted connectivity, Better uptime and prompt service support, suitable bandwidth for official applications and video conferencing activities.

24. Performance Security:- Successful Bidder has to submit a Demand Draft/Bank Guarantee for Rs. 25,000.00 (Twenty five Thousand rupees only) as performance security issued from a schedule bank which will be returned after completion of the assignment. The bank guarantee should be valid for 15 months from the date of notification of award.

25. Completion Period: - The services must be made operational within the date specified in the bidding document. Delay in start of service may attract punitive deduction @ 0.07 % per day of awarded value, which may be deducted from first quarter invoice. On further delay, agreement may be terminated.

Dispute Resolution:-The Purchaser and the Bidder shall make every effort to resolve amicably by direct informal negotiation of any disagreement or dispute arising between them under or in connection with the Agreement. If any of the disputes arising out of the agreement signed is not settled amicably, the courts in Patna, Bihar shall have the sole jurisdiction to settle the dispute.

27. Payment:-Payment shall be made within 45 days (excluding Sundays and Holidays) after satisfactory installation , integration and configuration and upon submission of bill in duplicate along with installation certificate duly signed by IT section of BRLPS as per the following payment chart:

- a) One Time Charges will be paid after successful installation. Integration and configuration (if applicable) ;
- b) One time charges will be billed in first quarter (if applicable)
- c) Annual Recurring Charges will be paid on quarterly basis.
- d) Proportionate amount will be deducted on account of outage as per SLA from running bills. SLA deduction will be calculated on monthly basis.
- e) Billing start date should be after successful installation and its verification by IT team of BRLPS.
- f) Billing period will be quarterly basis.
